CONDUCT OF COMPUTER-BASED LICENSURE EXAMINATION IN THE NATIONAL CAPITAL REGION AND PAPER-AND-PENCIL LICENSURE EXAMINATION IN DAVAO AND ROSALES FOR THE AUGUST 2023 SANITARY ENGINEERS LICENSURE EXAMINATION

WHEREAS, Section 7 (d) of Republic Act (R.A.) No. 8981 or the "PRC Modernization Act of 2000" empowers the Professional Regulation Commission (Commission) to administer and conduct the licensure examinations of the various regulatory boards in accordance with the rules and regulations it may promulgate and to determine and fix the places and dates of examinations;

WHEREAS, Section 7 (q) of R.A. No. 8981 also empowers the Commission to fully computerize all licensure examinations given by the various Professional Regulatory Boards and other operations of the Commission;

WHEREAS, the Commission proposed the project for in-house Computer-Based Licensure Examinations (CBLE) toward the full computerization of the conduct of the various professional licensure examinations;

WHEREAS, the Commission, through the Information and Communications Technology Service, developed the in-house program for CBLE;

WHEREAS, pursuant to Resolution No. 1589 (s. 2022), the Sanitary Engineers Licensure Examination is scheduled on August 29, 30 & 31, 2023 in the National Capital Region (NCR), Davao, and Rosales;

WHEREAS, the Commission continues to conduct the CBLE in NCR, which pioneered its implementation; however, PRC Davao and Rosales are still currently preparing to adopt the CBLE;

WHEREAS, during the meeting last July 19, 2023, the Professional Regulatory Board of Sanitary Engineering (Board) and the Commission discussed administering a hybrid examination due to the above-stated reason;

WHEREAS, the Board and the Licensure Office recommend to the Commission the conduct of a hybrid examination, that is CBLE in NCR while conventional paper-and-pencil examination in Davao and Rosales;


WHEREFORE, in view of the foregoing, the Commission **RESOLVES**, as it is hereby **RESOLVED**, to conduct a hybrid Sanitary Engineers Licensure Examination (CBLE in NCR and Paper-and-Pencil Examination in Davao and Rosales) on **AUGUST 29, 30 and 31, 2023**.
